# **Preparing for summer term codes**

To make sure that the summer headcount runs smoothly please ensure the following:


- Remind parents to reconfirm their eligibility when they are reaching the end of the validity period of their code (e.g. the end date is coming up soon)
- Ask parents, who are looking to take up the extended 15 hours from the summer term, to apply as early as possible during this term. This will help avoid any delays that might occur with the HMRC system.
- When offering an extended hours place you must validate the code first, via the portal, to ensure that it is a valid code (it is important to take notice of the start date, end date and grace period end date).

## Looking to offer funding?

If you are looking to offer funding for the first time please contact the early years team on <a href="mailto:early.years@acheivingforchildren.org.uk">early.years@acheivingforchildren.org.uk</a> stating that you would like to offer funded places. You will be asked to:

- complete and sign the <u>"conditions for inclusion onto the Directory of Providers"</u> agreement form
- request a <u>user account</u> for your setting to access the Provider Portal (which is how funding is claimed)

If you already offer funded places but would like to start offering extended 15 hour funding, please email <a href="mailto:early.years@achievingforchildren.org.uk">early.years@achievingforchildren.org.uk</a> confirming that you would like to offer this funding. Following this confirmation, we will activate the "30 hours" section on the portal which will allow your setting to claim for the funding at the next headcount.
