Ongoing engagement - feeding into improvements

Listening to the views of children and young people with SEND and their parents/carers:

- EHC Needs assessment process
- Annual Review process
- Phase Transfer process
- Meetings or communication with SEND team



How does this feed into improvements?

- Weekly QA activity - understand lessons learned
- Review feedback every quarter and decide actions to make improvements

EHCP Guide




- Developed to help children and young people understand what an EHCP is
- Support children and young people in sharing in the decision making and sharing their views
- Shared with the young people 'Easy Info' group for feedback and comments

Education, Health and Care Plans (EHCPs)



	Education What help you will get with learning. For example, you may have a teaching assistant in some lessons.
	Health What support you get to stay well. For example, you may take medications to stay healthy.
	Care What social care support you need. For example, you may have a social worker who sorts out extra support to help you at home.

You can have an Education, Health and Care Plan if you...

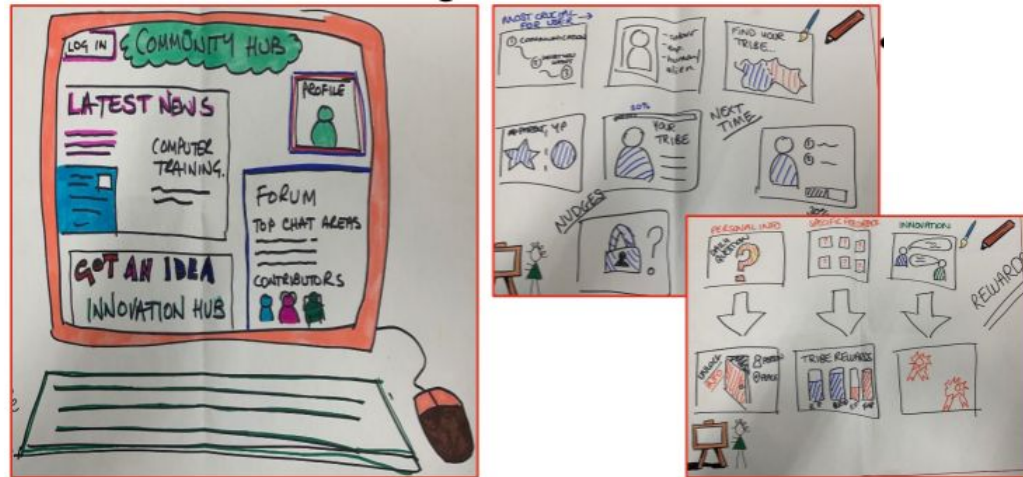
	Age between 0 - 25 years old.
	Have special educational needs or a disability.
	In school, college or training and need extra help.

Innovation workshop

How are we going to do this?


- Engage with young people with SEND - focus group session

SENCo Feedback

Listened to the views of SENCos and have taken action to support SENCos with the statutory assessment process.

Examples of actions:

- Developed a SENCo page on Local Offer website
- Specific training being planned to look specifically at outcomes

- Online consultation (parents/carers)

- Co-design the service specification
- Agree the outcome measures
