Dear parents and carers,

Flexible use of the Activity Fund for children and young people with disabilities.

We are writing to inform you that due to the current situation and restrictions in place, the way in which we offer the Activity Fund will be flexible. The Activity Fund usually provides £140.00 towards activities for eligible children and young people to take part in, each financial year. These activities include activities such as swimming sessions, annual passes, and activity clubs during term time and during school holidays. As these activities remain unavailable for the foreseeable future, we are offering alternative use of the Activity Fund until the usual activities can be accessed again.

- Applications must be for children and young people who are eligible for the Activity Fund (details can be found on the AfC SEND Local Offer https://kr.afcinfo.org.uk/local_offer).
- Applications must be for an activity that can take place safely within the home or outdoor space around the home.
- Applications must be for an activity that can be participated in more than once or the
 activity must have a lasting impact/ a benefit ongoing after the crisis e.g. a one off online
 class which teaches a skill that will be maintained, or reusable equipment.
- Applications must be for an activity that the child or young person enjoys.
- Applications can be made for up to £140.00 which is the maximum amount of Activity Fund
 that can be applied for per financial year (1st of April to 1st of March), if the full amount is not
 used during this current flexible funding time period, one further application can be made
 for once usual activities reopen for use of the remainder of the £140.00 towards activities
 for the eligible child or young person.
