

Barnet Children's Integrated Therapies Update for Special Schools and Additionally Resourced Provisions (ARP)

Dear Head teacher and SENCo

As we approach the last half term of this most unusual ending to the academic year, we would like to update you on how the NELFT CIT service will be providing support to your school and the children attending your setting.

NELFT, Barnet CCG and the London Borough of Barnet continue to work hard to ensure that the children who are most at risk and vulnerable continue to receive support from the NELFT's Barnet Children's Integrated Therapy (CIT) Team. Barnet CIT will continue to prioritise the high need interventions for children with and without EHCPs requiring urgent care and including:

- Swallowing and feeding difficulties requiring urgent assessment or review,
- Children discharged for Post-surgical interventions (Physiotherapy or Occupational therapy)
- Children who have had recent Botox interventions
- Hospital discharge requiring Equipment for health needs (Physio / OT)
- Acute Neurological patients- at risk of hospital admission

As a service we have a number of therapists who are shielding, ill or who have been redeployed which has an impact on the service capacity. While we are continuously monitoring our staffing capacity and adhering to the national guidelines, we recognise that it has been challenging for children and schools not to have their regular contact with their therapists.

We are now extending our service to offer support and advice via phone or video to special schools, ARPs and Parents with urgent queries regarding therapy input/programmes.

From the 8th of June there will be dedicated support available on the following days to support children and families attending special schools and ARPs:

- A discussion will take place with the school to take account of staffing in the school and what
 can be delivered in the school at this time as schools re-open/increase the numbers of pupils
 attending. Most of the support will continue to be offered virtually, at this time. We will
 review this on a regular basis.
- As per the published changes in the legislation for EHCPs, we will use 'reasonable endeavours' to deliver the service. These came into effect on 1st May and will continue until 25th September 2020. This may result in a child or young person's provision being adjusted to that which is set out in their EHC plan, for some, or all, of the time.
- Face to face contacts will be possible where this is urgently required and a Tele-review will not adequately support the need.
- For concerns around dysphagia please contact nem-tr.barnetcit@nhs.net or 0300 300 1821 and a dysphagia specialist will contact you.
- Annual Review advice in line with government guidance, the service will be prioritising
 completing a full AR where provision will be changing e.g. due to transition, etc. For others
 we will be sending an update, indicating what input there has been from our service and
 that therapy will continue as per the EHCP/last AR report.
