Maintained schools and academies 2, 3 and 4 year old funding entitlements

This form is used to collect information to assess the free childcare entitlement you are eligible for and your eligibility for Early Years Pupil Premium (EYPP) and Disability Access Fund (DAF). It must be completed and returned to your school in order for them to be able to claim the funding entitlements on your behalf. Some 2 year olds are entitled to 570 funded hours per year. Extended funding can only be claimed if you are eligible for 30 hours and have a valid code that covers the start of the funding term in which you are applying.

I understand that if I should remove my child from a funded place prior to the headcount date in each funding term (when the school submits their claims) the school will not receive funding and can therefore charge me for the full cost of my child's place as agreed within the school's terms and conditions up until the end of the agreed notice period.	
I understand that it is my responsibility to apply for a 30 hour eligibility code from HMRC and supply the code to the school within the required time frame for the funding period and renew my eligibility every 3 months or before the end date of the code.	
I understand that my child's funded place at the school nursery has been offered for the academic year and the school will continue to claim funding for subsequent terms up until the end of the academic year from the start of this agreement unless required notice is given.	
I understand that if I should remove my child from a funded place without the agreed notice period, subject to a maximum term of 1 month before the nominated headcount date (when the school submits the claims). The provider is still entitled to claim for the whole term and the funding cannot be claimed by another provider.

Data privacy
